The Ministry of Justice, Administration and Local Self-Government of the Herzegovina-Neretva Canton, acting upon the request of Dženana Dedić, for an entry of changes in the Register of Associations for the association "Udruženje Agencija lokalne demokratije", Mostar, pursuant to Article 33 paragraphs (1) and (2) of the Law on Associations and Foundations (Official Gazette of FBiH, 45/02) and Article 200 of the Law on Administrative Procedure (Official Gazette of FBiH, 2/98, 48/99), after having conducted an administrative proceeding, rendered the following

#### DECISION

The new Statute, amendments to the activities, extension of appointment to the person authorized to represent the association, and replacement of members of the management body of the association named "Udruženje Agencija lokalne demokratije" of Mostar, name in English: Local Democracy Agency, abbreviated name "LDA" of Mostar (Hereinafter: the Association), headquartered in Mostar at the registered office address: Fra Ambre Miletića 30, so that the following entries are made in the Register of Associations:

- a) new activities, i.e.:
- organizing seminars, round tables and conferences, alternative and informal forms of education and training;
- planning and organizing education and research;
- translating and publishing brochures, publications and books in accordance with the law;
- initiating and implementing national and international professional and cultural cooperation, with a special emphasis on the cooperation between cities and municipalities;
- 5) providing advisory services within the framework of the registered activity of the Association:
- 6) organizing and implementing campaigns and other media and public promotions;
- promotional activities of the Association in the field of culture (organization of exhibitions, concerts, promotion of books, publications, and poetry);
- 8) implementing the school scholarship award program.

The mentioned activities of the Association are carried out in the following areas, which are not explicitly listed here: democracy, protection and promotion of human rights, European integration, economy and sustainable development, migration, ecology, youth work, culture and art, tourism, informal education.

- b) extension of the appointment and the right to represent the Association:
  - Dedić Dženana, the Executive Director of the Association, for a new period of 4 years.

2. The changes were entered in the Register of Associations kept by this Ministry on page 293 book I. (stranica 293. Knjiga I. (prva)) of the Register of Associations, under registration number R-286/05, on 15/09/2021.

- 3. Other entries in the Register of Associations made based on the Decision of this Ministry, number: 03-03-03-05-UP1-276/16 of 01/06/2017 remain unchanged.
- 4. The changes, which are not subject to entry in the Register of Associations, have also occurred in the Association, and they relate to the adoption of the new Statute and the replacement of members of the Association's management body.
- 5. The Association is obliged to notify this Ministry of any subsequent changes: statute, name, seat and registered office address, activities, persons authorized to represent the Association, members of the management body, regardless of whether it is an extension of the appointment, new election, merger, demerger, transformation, or the winding up of the Association, within 30 days from the change day. A failure to report the change of data entered in the Register of Associations constitutes a violation of law.
- 6. The notice of an entry of changes in the Register of Associations will be published in the Official Gazette of Herzegovina-Neretva Canton.

#### Statement of Grounds

Dedić Dženana, the Executive Director and authorized person of the Association "Udruženje Agencija lokalne demokratije" of Mostar filed on 01/07/2021 the application for an entry of changes in the Register of Associations relating to the adoption of the new Statute, amendments to the activities, extension of appointment to the person authorized to represent the Association, and replacement of the members of the Association's management body.

Along with the application for an entry of changes in the Register of Associations filed as forms 6 and 7 (administrative fee of BAM 3,00 paid with tax stamps), she submitted the following sessional papers from the Assembly session held on 06/02/2021: Report from the session, Minutes from the regular annual meeting of the Board of Directors, Decision of the Board of Directors amending the Statute of the Association in two copies, Decision of the Assembly amending the Statute, Statute of the Association in two copies, Decision replacing the members of the Assembly, Decision appointing new members of the Assembly, List of newly appointed members of the Assembly, Decision extending the appointment of the Assembly Chair, Decision appointing a person authorized to represent the Association, Decision appointing a secretary to the Association, Decisions dismissing and appointing new members of the Board of Directors, List of members of the Board of Directors on the form number 5 with copies of their ID cards, and a proof of payment of the administrative fee and publication costs.

From the new Statute and the Decision amending the Statute, it is evident that they mainly refer to amending the activities.

It is evident from the decisions of the Assembly that the appointment and right to represent the Association of Dedić Dženana, the Executive Director of the Association, were extended, that the appointment of the Chair of the Assembly and secretary were extended, while the former members of the Board of Directors were relieved of their duties and new ones were appointed. The appointment of all members of the management body lasts four (4) years.

Upon inspection of the documents, it was established that all conditions for an entry of changes in the Register of Associations maintained by this Ministry were met, so based on Article 33 paragraph (2) of the Law on Associations and Foundations of the FBiH (Official Gazette, 45/02) it was decided as in the enacting clause of this Decision.

For this decision, an administrative fee of 50.00 BAM was paid to the HNC Budget in accordance with tariff number 12 paragraph (2) of the Law on Administrative Fees with Tariff

(Official Gazette of HNC, 2/13, 12/16, 3/20), with an indication that the fee is paid for issuing a decision to enter changes in the Register of Associations, to the account number: 3380002200005953 at UniCredit bank d.d. Mostar, revenue type 722121, budget organization 1501001.

The costs of the publication of the decision in the Official Gazette of HNC under point 6 of the enacting clause of the decision were paid by the applicant in accordance with Article 34 paragraph (2) of the Law on Associations and Foundations of FBiH (Official Gazette of FBiH, 45/02) in the amount of BAM 75.00, to the account number 3380002200005953 at UniCredit bank d.d. Mostar, revenue type 722121, budget organization 1501001.

### Legal Remedy

This Decision is final in the administrative proceeding, and may not be appealed, but an administrative dispute may be initiated. The administrative dispute is initiated by filing a lawsuit with the Cantonal Court in Mostar, within 30 days from the date of receipt of this Decision. The lawsuit is filed in two identical copies, with the original of this decision or a copy enclosed therewith.
